These expenses are paid at rates agreed within the Members Allowances Scheme. Members may claim costs when travelling on approved duties. The total amount of payments will vary from Member to Member depending on a number of factors. These factors include the distance that they live from the Police Authority at the Pacific Exchange in Hull and the extent to which they are required to attend Local, Regional and National meetings on behalf of the Authority.

Travel costs relate to payments made to the individuals and do not include expenditure arranged and paid for directly by the Police Authority.
